

# IRA Charitable Rollover Gift Instructions



## Benefits

Beyond being an easy way to make a gift, there are certain tax advantages to making an IRA Charitable Rollover Gift. The gift distribution is not counted as part of your income and thus not subject to income tax. This helps reduce your adjusted gross income (which can have tax benefits in itself) and means you receive the equivalent of a charitable deduction for your gift, even if you do not itemize on your tax return. In addition, the transferred funds count towards your annual Required Minimum Distribution (RMD).

## For your gift to qualify as an IRA charitable rollover

- You must be at least 70 ½ years of age on the date of the gift
- You cannot exceed more than \$108,000 in rollover gifts in a calendar year
- You cannot take possession of the funds prior to gifting them to a charity

## To make an IRA charitable rollover gift to Fred Hutchinson Cancer Center

- Contact your IRA administrator directly. They may have a standard form to use or other specific instructions.\* You may need our Tax ID #: 91-1935159.
